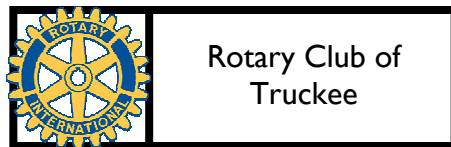

2010-2011 New Member Policy and Application



2010-2011 New Member Policy

- ▶ Any Active Member may at any time bring a guest to Rotary but may not bring any one guest more than three times to avoid the expectation of membership proposal.
- ▶ A Proposed Member must never be told he or she is being proposed until passing the 7-day notice process—this is a confidential club process.
- ▶ A Proposed Member MUST be proposed by a current Member; volunteers without sponsors are not allowed.
- ▶ Rotary Membership applications will be considered, provided the following criteria are met: (1) Membership in good standing at another Club if application is made within 30 days of resignation from prior club; (2) Transfer from another Rotary Club provided letter is received from prior Club indicating Member is in good standing; (3) Any Proposed Member not a prior Rotary Member or, a prior Rotary Member not meeting criteria #1 and #2 above, must be a member of the Truckee Community for a minimum of 6 months prior to acceptance and commencement of the application process.
- ▶ A standing Club Membership Committee will be maintained with a Chairperson and no less than 4 additional members to review all proposed membership applications.

MEMBERSHIP PROCEDURE

The Sponsoring Member must submit a completed application together with three (3) letters of recommendation from current Club Members and a signed Sponsorship Agreement to the Membership Committee for consideration. If accepted, the application is forwarded to the Board of Directors.

The Board of Directors reviews the application and, if the Board agrees by majority decision to approve the application, it goes to Classification for assignment. When Classification returns the application for approval, the application moves to the Board for secondary review.

If there is no majority decision by the Board, and the application has not been withdrawn, the application is submitted to the Membership Committee for confidential review. If the Membership Committee fails to return to the Board with a recommendation for action on the application, the application is considered denied.

If the Board agrees, by consensus action, to submit the application to the Club Membership, the application is broadcast in a Seven day notice to the entire membership. Current Club Members have seven (7) days to review the application and contact the Membership Committee with any objections.

If after the seven (7) day notice there are no objections, the Sponsoring Member notifies the Proposed Member and, if there is interest, a Rotary Information Meeting is scheduled. If, following the Rotary Information Meeting enthusiasm and interest is shown, the Proposed Member is welcomed as an Active member through the formal induction process.

If objections are voiced, the objecting Member comes before the Board to present his/her objection. If there is no Board consensus on action, the application is then returned to the Membership Committee for further confidential review. If the Membership Committee fails to return to the Board with a recommendation for action on the application, the application is considered denied.
